**APPLICATION FOR INCOME TAX EXEMPTION APPROVED: TRADE AND INVESTMENT KWAZULU-NATAL.**

The South African Revenue Service (SARS) would like to confirm that your application for exemption from income tax has been approved. Your Income Tax Exemption has been granted in terms of section 10(1)(cA)(i) of the Act.

The following exemptions also apply and are limited to:

1. Donations made to or by the PBO are exempt from Donations Tax in terms of section 56(1)(h) of the Income Tax Act.
2. Exemption from the payment of Estate Duty in terms of section 4(h) of the Estate Duty Act No.45 of 1955.

In order to maintain your exempt status, the following conditions must be complied with:

1. Submit an annual Income Tax Return (IT12EI) by the due date via SARS eFiling or manually. Your IT12EI can be obtained by:
  - o Registering online at [www.sarsefiling.co.za](http://www.sarsefiling.co.za) to access, request and submit the IT12EI electronically
  - o Calling the SARS Contact Centre on 0800 00 SARS (7277)
  - o Requesting an IT12EI by contacting the TEU on [teu@sars.gov.za](mailto:teu@sars.gov.za) or calling (012) 483 1700
  - o Requesting an IT12EI by visiting your local SARS branch.
2. SARS must be informed in writing within 21 days of any change in registered particulars (e.g. Representative, change of name, address, trustee details, office bearers, etc.).

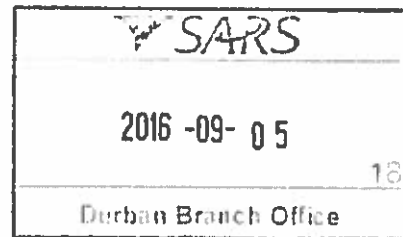

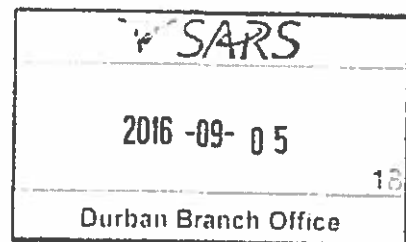
